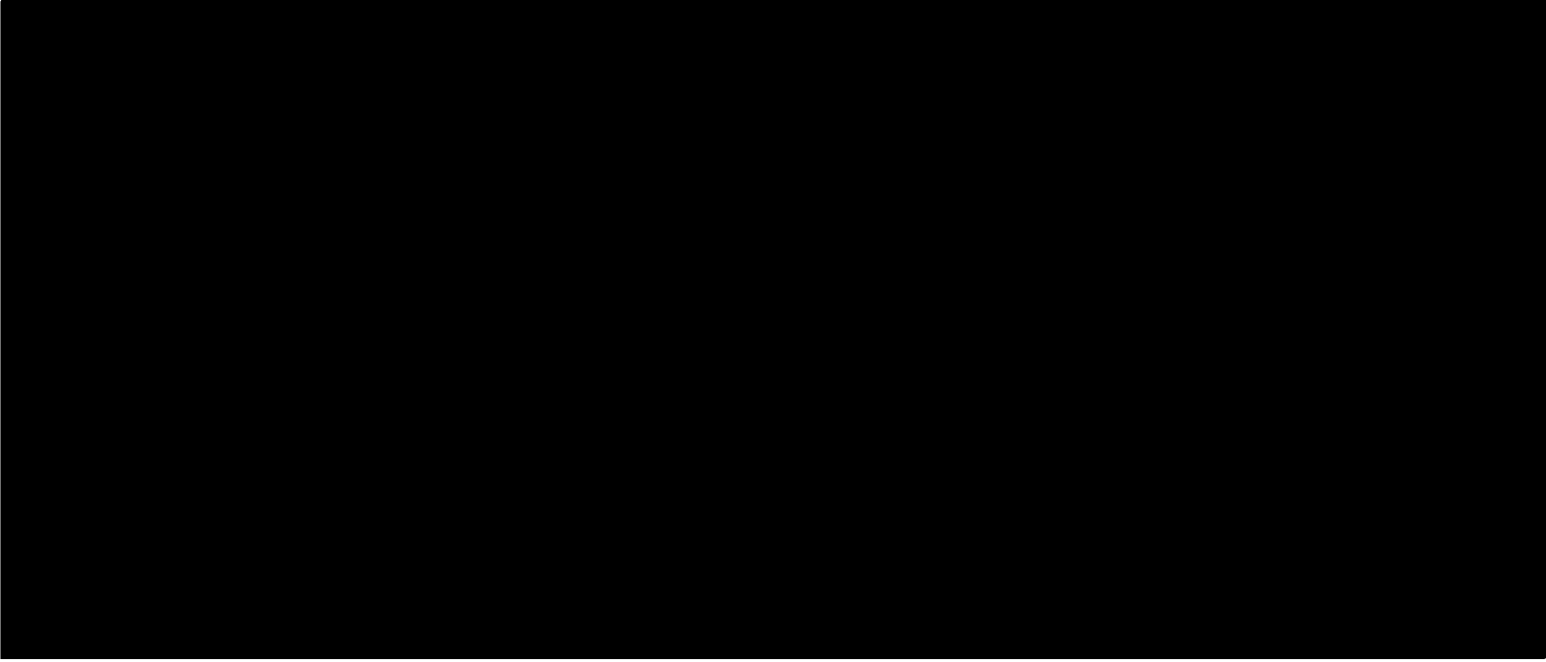

You'll see that this version still requires work on our part—the footnotes are not in operation, we have not attached all the appendices, and we are awaiting input from several important partners who are working hard to finish their inputs.
