

Transcript of 911 Recording Winslow Homicide June 6, 2011

Automated Voice: June 6, 2011 19 hours 52 minutes 1 second

DPS Dispatch: 911 where is the emergency?

Victim: Yes, I need a police officer out here, Winslow, [REDACTED]

DPS Dispatch: [REDACTED] in Winslow?

Victim: Yup.

DPS Dispatch: Okay. What's going on there?

Victim: The domestic situation, my husband's threatening to kill me and my friends -

DPS Dispatch: What's your phone number?

Victim: My phone number is [REDACTED], he has a gun

DPS Dispatch: Hold on

Phone Ringing

Waterville Dispatch: Waterville Regional Communications Center.

DPS Dispatch: DPS, transferring a domestic at [REDACTED] in Winslow, you're on with the female now.

Waterville Dispatch: Okay.

Victim: Hello

Waterville Dispatch: Ma'am?

Victim: Yes.

Waterville Dispatch: Hi is this your residence?

Victim: Yes

Phone Disconnects.

Automated Voice: June 6, 2011 19 hours 55 minutes 2 seconds

DPS Dispatch: Department of Public Safety.

Waterville Dispatch: Hey, it's Waterville Comm., you guys transferred me a cell call out in Winslow, [REDACTED] did you get a call back number on that?

DPS Dispatch: Let me check, alright, hold on.

Automated Voice: June 6, 2011 19 hours 55 minutes 26 seconds

DPS Dispatch: [REDACTED]

Waterville Dispatch: Hmm. Hmm.

DPS Dispatch: [REDACTED]

Waterville Dispatch: Did she give you a name or anything or do you know?

DPS Dispatch: Did she give you a name Jess? Hold on, we're looking.

Waterville Dispatch: Okay.

DPS Dispatch: No name, just a domestic situation and husband is threatening to kill her.

Waterville Dispatch: Yeah he was holding a gun to her head when it got disconnected so -- alright thanks.

DPS Dispatch: You're welcome.

Waterville Dispatch: Bye.

DPS Dispatch: Bye.

Automated Voice: June 6, 2011 19 hours 58 minutes 1 second

DPS Dispatch: 911 what is the address of the emergency?

Male Witness: Yeah some guy just shot his wife over here on Marie Street.

DPS Dispatch: What town?

Male Witness: In Winslow.

DPS Dispatch: In Winslow?
Male Witness: Yes.
DPS Dispatch: What is the address on Marie Street?
Male Witness: It's right on the corner of Marie and Beck.
DPS Dispatch: Okay. I'm going to put you through to Waterville Police. What's the number you're calling from?
Male Witness: [REDACTED].
DPS Dispatch: Do not hang up okay?
Male Witness: Pardon me?
DPS Dispatch: Do not hang up.

Phone Ringing

Waterville Dispatch: Communications Center.
DPS Dispatch: Hi, DPS Augusta transferring a caller in Winslow on [REDACTED], advising that a male just shot his wife.
Waterville Dispatch: Okay.
DPS Dispatch: The number is [REDACTED].
Waterville Dispatch: Okay. Hello.
DPS Dispatch: Go ahead sir. Sir are you there?
Male Witness: Yes I am.
DPS Dispatch: Okay, you're on with Winslow Police.
Male Witness: He just shot her again.
Waterville Dispatch: He's shooting her again?
Male Witness: He just shot her and now he's walking down to his house.
Waterville Dispatch: Is he outside or inside?

Male Witness: He is outside, they're on the neighbor's lawn right now, she is lying on the neighbor's lawn, he's walking back to his house.

Waterville Dispatch: Okay, can you give me a description of what he's wearing?

Male Witness: He's wearing tan pants with a white t-shirt. He's from the -- he's in the military, I know that for sure.

Waterville Dispatch: Okay, do you know his name?

Male Witness: I don't know - these are new neighbors that just moved in.

Waterville Dispatch: They just moved in?

Male Witness: About - sometime over the last winter.

Waterville Dispatch: Okay, I'll have the officer head over there.

Male Witness: If he stops at [REDACTED] I can show him right where he lives.

Waterville Dispatch: Okay. I'll let him know that.

Male Witness: Thank you.

Waterville Dispatch: Thank you.

Male Witness: Bye.

Automated Voice: June 6, 2011 19 hours 59 minutes 45 seconds

DPS Dispatch: 911 what is the address of the emergency?

Female Witness: It's on the corner of Marie and Beck Street in Winslow, a woman's been shot, her husband shot her numerous times.

DPS Dispatch: Alright, I am going to put you through to Waterville Police, do not hang up, okay. What is the number that you are calling from?

Female Witness: [REDACTED]

DPS Dispatch: Alright, hold on.

Female Witness: Thank you. She's dead.

Phone Ringing

DPS Dispatch: Marie and Clifton right?

Female Witness: Marie - Marie and Beck Street.

DPS Dispatch: Marie and Beck Street.

Waterville Dispatch: Waterville Police Department

Female Witness: Hi – there's -

DPS Dispatch: Hi I'm transferring another caller at [REDACTED] in reference to the shooting

Waterville Dispatch: Okay what can I do for you?

Female Witness: There's a woman that's on the lawn her husband -

Automated Voice: June 6, 2011 20 hours 2 minutes 55 seconds

DPS Dispatch: 911 where is the emergency

Female Witness: Marie and Buck Street in Winslow

DPS Dispatch: Marie and Buck Street in Winslow?

Female Witness: Yes.

DPS Dispatch: What number are you calling from?

Female Witness: [REDACTED] - [REDACTED]

DPS Dispatch: Okay.

Female Witness: It's taking them forever to get here; she's lying on the lawn. The cops were just here a little while ago, it's taking forever.

DPS Dispatch: They're on their way ma'am they are on their way. Do you have any updates for us?

Female Witness: I don't – she's – she's – oh, here they come.

DPS Dispatch: Is she deceased?

Female Witness: I can't tell, because I don't dare go out because I'm afraid I'm going to get shot.

DPS Dispatch: Okay. Make sure you keep your doors locked ma'am

Female Witness: What?

DPS Dispatch: Make sure you keep your –

Female Witness: Now they're not even going to the right place, their taking off – going to the wrong place.

DPS Dispatch: Okay ma'am I'm going to put you through – hold on.

Female Witness: Okay.

Phone Ringing

DPS Dispatch: Ma'am

Female Witness: The guy's running – the guy's friggin' running.

DPS Dispatch: The guy's running now.

Waterville Dispatch: Waterville Communications Center what is the address of your emergency?

DPS Dispatch: I'm transferring a neighbor at [REDACTED] – she is stating that the guy is now running.

Waterville Dispatch: Running?

DPS Dispatch: He is running.

Waterville Dispatch: Okay, where is he running?

Female Witness: Did you see where he went running - _____ where'd he go, where'd he go? Okay I guess they have other neighbors telling them where he went.

Waterville Dispatch: Okay. Hello, hello

Female Witness: Hello, I don't know where - I don't know where the guy is now.

Waterville Dispatch: Okay you don't know where he is at this time?

Female Witness: I don't know where he is nope; he's running through the neighborhood somewhere.

Waterville Dispatch: Do you know what he was wearing?

Female Witness: He had on brown pants – brown pants white shirt.

Waterville Dispatch: Brown pants white shirt, okay, we've got - we have Waterville Officers on the way as well as the Winslow Officers

Female Witness: Okay.

Waterville Dispatch: we are looking for him, if you have any further information call us right back okay.

Female Witness: Okay. Thank you.

Waterville Dispatch: Thank you.

Female Witness: Yup, Bye -bye.
